Legacy giving with Pegasus

A gift in your will is the most common legacy gift, and there are 3 types:

Specific: provides the organization with a specific dollar amount or piece of property.

Residual: provides the organization with the remainder, or a portion of your estate that remains, after all debts, taxes, expenses and other bequests have been paid.

Contingent: you make a provision in your will that your gift only takes effect if your primary intention cannot be met (i.e. if the primary beneficiary and alternate beneficiaries do not live longer than you).

There are a variety of other types of planned gifts, including **named endowments, gifts of shares or RRSPs/RRIFs, DAFs and more**. Your advisors are instrumental in helping you choose the gift that is best for you.
